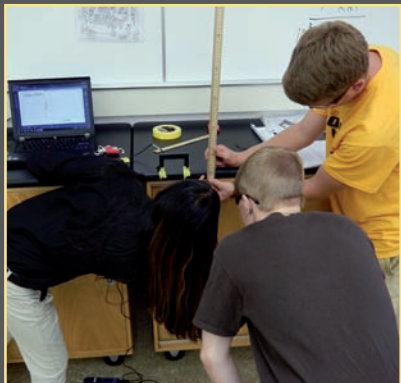
# What *is the Solanco Education Foundation?*
